## 10 01 Original Photograph

- Applicants must not submit additional photographs than required.
- 2. Photographs must be affixed.
- Photograph for Visa cannot be the same photograph that is already in your passport
- Recent Passport photo taken within the past 6 months, showing current appearance
- 2 inches by 2 inches size
- Photographs NOT to be stapled and must NOT be adhesive taped
- Must be in color.
- NO Scanned / Color printed photograph
- Must be against white background
- · Must show full face, front view
- Must be taken in normal street attire.
- Photograph has to be an original and printed on GLOSSY PHOTO PAPER ONLY
- Uniforms should not be worn in photographs except religious attire that is worn daily.
- If you normally wear prescription glasses, a hearing device, wig or similar articles, they should be worn for your picture.
- Dark glasses or non-prescription glasses with tinted lenses are not acceptable unless you need them for medical reasons. A medical certificate may be required.
- Glare on eyeglasses should be avoided with a slight upward or downward tilt of the head.
- Do not wear a hat or headgear that obscures the hair or hairline. Head coverings are not permitted except for religious reasons, but the facial features from bottom of chin to top of forehead and both edges of the face must be clearly shown.

- Applicants who have dual citizenship with the US and another country must apply only on their US passport if they are applying in USA.
- · Actual original signed passport.
- The passport must be valid for 6 months at the time of visa application.
- The Passport must have at least 2 blank Visa pages available for India Visa stamp.
- Amendment pages in back of the passport are not suitable for Indian Visa.
- Passport / Pages must not be torn, separated, frayed or altered.
- Photocopy of passport pages that contain passport information and signature of the applicant.

Proof of address to match with present address as per application.

ANY ONE Proof of Address from either of the parents OR a Legal guardian has to be submitted

State Issued ID (with address)

OR

Driving license (validity for at least 6 months pending)

OR

Utility Bill - Water OR Electricity OR Gas (should be recent, no more than 3 months old)

OR

- Valid lease signed by landlord and tenant (No monthly lease documents allowed, only Year to Year)
- For College / University Students living on campus in University housing / dormitories, a letter from your institution on the institution letterhead explaining the exact address that you presently reside in.
